

Student Financial Success Hero 2020 Contest Terms & Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility:** This contest is open only to those who sign up through the <http://go.campuslogic.com/sfshero> webform and who are 18 years of age as of the date of entry and must be an employee at a higher education institution. The contest is only open to legal residents of The United States and is void where prohibited by law. Employees of CampusLogic, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the contest.
